## 1) MEMBERSHIP

- a. Ordinary Members — Ordinary membership shall consist of 2 Groups:

### **Group 'A'**

Associations of Organisations of exporters/importers and/or associations or organisations or organisations of producers/manufacturers of Malaysian export products which are concerned with matters on shipping and freight rates; and

### **Group 'B'**

Associations or organizations or Government agencies which in the opinion of the Management Committee of the Council can contribute towards the achievement of the objective of the Council, may also become Members of the Council; and

- b. Associate Membership — other associations/ societies and individuals.

## 2) APPLICATION FOR MEMBERSHIP

An application for membership shall complete an application form as may be prescribed by the Management Committee for submission to the Secretary General. All applications for membership will be placed before the Management Committee and its decision based on at least two-thirds majority of those present shall be final

## 3) SUBSCRIPTION FEE

An entrance fee and annual subscription fees shall be payable by Ordinary and Associate Members at such rate as may be determined by the Management Committee.

- The current rate is RM1000 per organisation.

## OBJECTIVES

- To protect and promote the interests of exporters, importers, producers and manufacturers in Malaysia in relation to the transportation of goods;
- To secure the greatest possible cooperation between Malaysian exporters, importers, producers and manufacturers and any other entities concerned with the transportation of goods
- To bring together exporters, importers, producers and manufacturers in all parts of Malaysia on a common platform for consultations on transportation problems affecting them;
- To search for more efficient systems in transport operation with a view of reducing costs;
- To seek alternative means of shipment where feasible;
- To suggest measures for the long-term improvement and development of shipping and other transport services to serve Malaysia's trade;
- To engage into such consultations and/or negotiations, as may be deemed necessary with shipowners and other with regard to the arrangements for, and the terms and conditions applicable to overseas cargo shipping;
- To do such other lawful things as are incidental or conducive to the attainment of the above objects; and
- To hold consultation and collaborate with other shippers councils or other regional organisations in pursuance of mutual benefits and to further the interest of Malaysian shippers.
